TEMPORARY PISTOL PERMIT APPLICATION INSTRUCTIONS

Revised 2/17/2026

To process your request for a Temporary State Pistol Permit, the following items must be completed and submitted to the Cheshire Police Department Records Division:

- Application for Temporary State Pistol Permit (Must use DPS-799-C Revised 7/16/2024)
- A copy of a Training Certificate attesting to your competence with a handgun, signed by a NRA Certified Pistol Instructor or another recognized training organization. Name and ID# of the instructor must be listed in Proof of Training section of the application.
- New 7/1/24: To be in compliance with Pubic Act 23-53, the NRA Training Certificate must be dated within two years of the date of your application submission.
- New 7/1/24: To be in compliance with Pubic Act 23-53, the instructor must also sign the separate "Certificate of Completion" document which indicates the following was instructed: (1) safe storage in the home and in vehicles; (2) lawful use of firearms; and (3) lawful carrying of firearms in public
- FBI Privacy Act Statement
- Noncriminal Justice Applicant's Privacy Rights
- Agency Privacy Requirements for Noncriminal Justice Applicants
- A copy of your Birth Certificate or Passport.
- Proof of residency in the Town of Cheshire; i.e. a copy of tax bill, utility bill, legal tender documentation/check book. Note: a Driver's License will not be accepted as proof of residency.
- A copy of your Driver's License or State of CT ID Card.
- If you have ever been a member of the Armed Forces and were discharged, attach a copy of your DD-214 that shows your discharge status as "Honorable Discharge".

Payment

Application processing fee: A cashier's check or money order in the amount of \$70.00 made payable to the Town of Cheshire must be submitted with your application.

Fingerprinting

Fingerprinting services are available Mondays and Saturdays from 7:00am to 11:00am and 3:00pm to 7:00pm at the Cheshire Police Department. Once you have completed your application and supporting documents, you must come to the Cheshire Police Department during fingerprinting hours where you can pre-enroll for fingerprinting and pay the state fees online by credit/debit card. The service code specific for Cheshire Police Department pistol permit fingerprint applicants will be provided on the day you submit your completed application and get fingerprinted. Give yourself enough time to complete this task using your own device (i.e. smartphone, tablet, laptop). Please note, once you complete the pre-enrollment process and pay online, there are no refunds.

NOTE: The processing of the Temporary Pistol Permit Application could take up to 14 weeks to complete. Once a temporary permit has been issued, you will be required to apply within sixty (60) days for a State Permit. Incomplete applications will be returned. Agency Privacy Requirements for Noncriminal Justice Applicants

Authorized governmental and non-governmental agencies/officials that conduct a national fingerprint-based criminal history record check on an applicant for a noncriminal justice purpose (such as employment or a license, immigration or naturalization matter, security clearance, or adoption) are obligated to ensure the applicant is provided certain notices and that the results of the check are handled in a manner that protects the applicant's privacy. All notices must be provided in writing.¹ These obligations are pursuant to the Privacy Act of 1974, Title 5, United States Code (U.S.C.), Section 552a, and Title 28, Code of Federal Regulations (CFR), Section 50.12, among other authorities.

- Officials must ensure that each applicant receives an adequate written FBI Privacy Act Statement (dated 2013 or later) when the applicant submits his/her fingerprints and associated personal information.²
- Officials must advise all applicants in writing that procedures for obtaining a change, correction, or update of an FBI criminal history record are set forth at 28 CFR 16.34. Information regarding this process may be found at <https://www.fbi.gov/services/cjis/identity-history-summary-checks> and <https://www.edo.cjis.gov>.
- Officials must provide the applicant the opportunity to complete or challenge the accuracy of the information in the FBI criminal history record.
- Officials should not deny the employment, license, or other benefit based on information in the FBI criminal history record until the applicant has been afforded a reasonable time to correct or complete the record or has declined to do so.
- Officials must use the FBI criminal history record for authorized purposes only and cannot retain or disseminate it in violation of federal statute, regulation or executive order, or rule, procedure or standard established by the National Crime Prevention and Privacy Compact Council.³

The FBI has no objection to officials providing a copy of the applicant's FBI criminal history record to the applicant for review and possible challenge when the record was obtained based on positive fingerprint identification. If agency policy permits, this courtesy will save the applicant the time and additional FBI fee to obtain his/her record directly from the FBI by following the procedures found at 28 CFR 16.30 through 16.34. It will also allow the officials to make a more timely determination of the applicant's suitability.

Each agency should establish and document the process/procedures it utilizes for how/when it gives the applicant the FBI Privacy Act Statement, the 28 CFR 50.12 notice, and the opportunity to correct his/her record. Noncriminal Justice Applicant's Privacy Rights

As an applicant who is the subject of a national fingerprint-based criminal history record check for a noncriminal justice purpose (such as an application for employment or a license, an immigration or naturalization matter, security clearance, or adoption), you have certain rights which are discussed below. **All notices must be provided to you in writing.**¹ These obligations are pursuant to the Privacy Act of 1974, Title 5, United States Code (U.S.C.) Section 552a, and Title 28 Code of Federal Regulations (CFR), 50.12, among other authorities.

- You must be provided an adequate written FBI Privacy Act Statement (dated 2013 or later), by the agency that will receive your criminal history results, when you submit your fingerprints and associated personal information. This Privacy Act Statement must explain the authority for collecting your fingerprints and associated information and whether your fingerprints and associated information will be searched, shared, or retained.²
- You must be advised in writing of the procedures for obtaining a change, correction, or update of your FBI criminal history record as set forth at 28 CFR 16.34.
- You must be provided the opportunity to complete or challenge the accuracy of the information in your FBI criminal history record (if you have such a record).
- If you have a criminal history record, you should be afforded a reasonable amount of time to correct or complete the record (or decline to do so) before the officials deny you the employment, license, or other benefit based on information in the FBI criminal history record.
